PROPOSED CONSTRCTION OF CREMATORIUM AT PORE, ATHURUGIRIYA FOR KADUWELA MUNICIPAL COUNCIL

- 1. Municipal Commissioner on behalf of Kaduwela Municipal Council now invites sealed bids from eligible and qualified bidders for **Proposed Construction of Crematorium at Pore, Athurugiriya for Kaduwela Municipal Council** as described below and estimated to cost **Rs. 35.0 million** approximately. (Excluding VAT)
- 2. The eligible bidders shall comply with the following qualification criteria and shall not have been blacklisted.

- 5. A complete set of bidding documents could be purchased from the Municipal Engineer's Department of Kaduwela Municipal Council, Kaduwela, by interested bidders on submission of a written request to the Municipal Commissioner, Kaduwela Municipal Council, New Kandy Road, Kaduwela from **09.00 hrs** to **15.00 hrs** on working days **from 21.09.2021 to 11.10.2021** upon payment of non-refundable fee in cash, as given in the table above.
- 6. A site inspection will be held on **30.09.2021 at 10.00 hrs.** at **Pore Cemetery** followed by a pre-bid meeting at the Municipal Commissioner's office in the Kaduwela Municipal Council. Bidders or their authorized representatives can participate for the said meeting.
- 7. All bids must be accompanied by a Bid Security of LKR. 400,000/- in favor of the Municipal Commissioner, Kaduwela Municipal Council, Kaduwela. Bid Security shall be an unconditional on demand guarantee obtained only from a reputed Bank or an Insurance Company in Sri Lanka. Bid Security shall be valid till **08.02.2022**.
- 8. Sealed bids in original with duplicate should be deposited in the Tender box kept at the Municipal Engineer's Department, Kaduwela Municipal Council to receive at or before **10.00 hrs. on 12.10.2021**. Bids will be opened soon after the closing. Bids received after closing time will be rejected.
